Summary	<p><b>A misleading piece intent on painting ivermectin as “dangerous horse paste”.</b></p> <p><b>Let’s be clear: Ivermectin is also used for animals.</b> Just like aspirin and antibiotics are used for animals, ivermectin is a very effective human medication. It is FDA and MHRA approved and a <b>WHO “Essential Medicine”</b>, eradicating horrific illnesses through 4 billion doses given to people over 40 years. It continues to protect millions and in normal doses is not ‘dangerous’; it is very safe, <u>a hundred times safer than aspirin</u>.</p> <p>Ivermectin has strong antiviral and anti-inflammatory properties and features in early covid treatment protocols from expert clinicians worldwide - not ‘right wing anti-vax extremists’ as Atkins maliciously portrayed advocates.</p> <p><b>He falsely claimed</b> that there is ‘no evidence’ for ivermectin for Covid. There is lots of it; over 64 studies so far. 45 are peer-reviewed and 35 are RCTs, involving 26,509 patients. Conducted by world-class researchers and medical professionals, they include gold standard meta-analyses in published and peer-reviewed journals supporting ivermectin for covid. All have failed to be noticed by Atkins’ team.</p> <p>The real truth is that the introduction of (human) ivermectin could save countless lives and remove many of the restrictions surrounding covid, just as health authorities in India, Mexico and many other countries have discovered.</p> <p>But these inconvenient facts don’t suit Atkins’ ‘horse paste’ narrative – provocatively making 30 references to animals. The article by the New York Times he quotes has been debunked. This programme is poorly researched and biased. <b>The BBC needs to uphold its responsibilities as a public broadcaster or continue to lose the public trust.</b></p>

<p><i>Obsessive focus on dangers especially 'large' doses of the animal version of ivermectin.</i></p>	<p><b>We 100% agree, don't use animal medicines.</b> No serious advocate of ivermectin is suggesting that.</p> <p>Strangely, the editorial team chose to tell this as mainly an animal medicine story following a now debunked press release in the USA.</p> <p>Horses, cows and other animals are mentioned or depicted 30+ times. That's 162%</p> <p>But what was completely missed out was that this increase is a <b>fraction</b> of 2,344% increase in reported usage – 88,000 prescriptions were mentioned. You would expect adverse reports to rise by a similar amount but they didn't. VAERS (adverse drug reactions) reports also didn't increase.</p> <p>Why are six telephone calls to poison control about Ivermectin newsworthy, yet over 100,000 calls to poison control on Tylenol/Paracetamol each year are not. <p><i>"It doesn't work"</i></p>	<p><b>It does work, in fact.</b></p> <p>Real-world examples: Cases in Uttar Pradesh (pop &gt; 230 million) have dropped from 37,944 on April 24 to 5,964 on May 22 - a decline of 84%. despite only 15% vaccination rates.</p> <p>In Peru the same, when ivermectin was rolled out it drastically shrunk the death and hospitalisation toll. When it was stopped, by politicians, they rose again.</p> <p>Perhaps a cursory glance by the editorial team would have surfaced the 60+ studies that show efficacy of the human version in humans, rather than the recycled and debunked story in the US media about the animal version in humans. Rather than print a retraction they just deleted the info.
